

General Terms & Conditions:

Daniel Slade Photographic is a subsidiary of Daniel Slade Limited Registered in England No: 6702713

From this point onwards Daniel Slade Photographic will be referred to as DSP

- 1, Any additional charges incurred, will be recovered from the client.
- 2, No additional travelling expenses will be incurred unless previously stated.
- 3, DSP will recover the cost of accommodation and travelling expenses where the ceremony is at a distance of 50 Miles (round trip). It may be necessary to travel on the evening prior to the wedding to avoid traffic and other problems, also it may be necessary to stay overnight where a wedding runs late. The cost of accommodation shall be reimbursed from the client.

Payment:

- 1, Final agreed package amount will depend on the precise requirements of the client.
- 2, A deposit of £300 made payable to Daniel Slade at time of booking, once cleared DSP will be the sole photographers for your day and will not book any other work for your photographer on that day.
- 3, The deposit is non returnable.
- 4, The final balance for photographic services is payable 28 days prior to the wedding date, it is your responsibility to pay DSP when monies are due.
- 5, Payments are non refundable
- 6, Non payment of the final balance 28 days prior to the wedding date constitutes a breach of contract from client. Any previous contract will become null and void.
- 7, All prices and packages are subject to change. Prices are adjusted periodically; future bookings will be priced at the time of booking.
- 8, Future re orders will be priced at the time of each order.
- 9, Returned cheques will incur a £50.00 charge.
- 10, You authorise DSP to hold your details on our database for 20 years (for the purpose of any reprints).

Exclusivity:

- 1, DSP shall be the exclusive photographer retained by the client.
- 2, Family and friends are permitted to take photographs as long as they do not disturb or disrupt or interfere with the photographers duties.
- 3, The DSP photographer(s) have the right to kindly ask the person obstructing to refrain from doing so, in order for DSP photographer(s) to continue their duties.
- 4, It is our duty to provide you with a unique service.
- 5, Any breach of this agreement will constitute a reason for non completion of the booking with no liability to DSP or its photographers.

Inherent Quality:

- 1, Clients should be aware that colour dyes in photography may fade or discolour over a period of time due to inherent quality of dyes and insufficient care and preservation of prints and albums.
- 2, The photographer will not be liable for degradation of images due to poor handling and insufficient care.
- 3, All albums need to be kept at room temperature, stored in a box away from heat and direct sunlight as these will reduce the life of your albums and prints. DSP accepts no liability.
- 4, If the photographer(s) are unable to fulfil the role of photographer on the day due to unforeseen circumstances DSP will endeavour to find a replacement. Should this not be possible a full refund will be given to the client but no further liability will be sought with respect to the agreement.
- 5, If the client cancels no refund shall be given.
- 6, This limitation shall apply to in the event photographic materials are damaged, lost, stolen, camera malfunction or any other damage without fault of DSP or its photographers.
- 7, DSP cannot be held responsible for images and photography sessions being disrupted by adverse/unfavourable weather conditions.
- 8, DSP and its photographers shall not be liable for any amount in excess of the retail value of your booking.
- 9, DSP may substitute photographers to take photographs at your wedding in the event of photographers illness, your contract will remain with DSP in all cases.
- 10, All re orders shall be an extension of this contract.
- 11, All re orders shall be paid for in advance when placing the order with DSP.
- 12, DSP and its photographers will not be held responsible for the lack of coverage caused by the bride, groom, wedding party, guests not being on time or interfering or restricting the photographers duty. In some cases people not present may be digitally added to your photographs, we will be able to advise you on this.
- 13, DSP will not be held responsible for restrictions placed on photography by the church, ceremony venue, reception venue etc.
- 14, The photographer cannot guarantee any specific image, background or group arrangement.
- 15, The photographer will not be held responsible for customer disappointment of agreed album and images as long as they are technically acceptable and will face no liability.
- 16, Any announcement made that will affect your photography including the day, timings, venues etc should be made in writing to DSP as soon as possible.
- 17, Any circumstance not brought to our attention that affect the outcome of the wedding photography will not be the responsibility of DSP
- 18, A map should be provided if necessary to prevent the photographers getting lost, contact details of all vendors should be provided. DSP will not be held responsible for being miss-informed.
- 19, Due to technical processing, DSP cannot guarantee exact colour matching.
- 20, DSP cannot be held responsible for print selection errors whether reprints or album prints.
- 21, DSP will take no responsibility for albums that have incorrect images due to client error. A charge will be made for re album design.
- 22, DSP cannot be held responsible for the damage to DVD's provided. Appropriate care is the clients responsibility.
- 23, All albums, prints & Discs should be collected in person from DSP.
- 24, DSP accepts no responsibility for the reliability of the post. We cannot be held responsible for loss or damage of mail, prints, albums, frames and disks etc that are sent through the post. A courier service can be arranged for which the client shall reimburse charges incurred by DSP.
- 25, It is advisable that you make a copy of your booking form for your own benefit.
- 26, All of the above agreements apply to all our work.
